TERMS AND CONDITIONS

TOTAL TOUR PRICE: The tour price is based on land rates, cruise rates, and rates of exchange in effect Jan. 2026. **International airfare is not included.** All rates are subject to change without prior notice. Should the rates go up or down, an adjustment would be made prior to departure. As all services are contracted and prepaid on a group basis, no refunds can be granted for any accommodations, services or events that are not used. If you deviate from the tour, no consideration can be given to a refund for unused services. This tour is subject to a minimum number of pilgrims. Should fewer than 20 participate a price adjustment may be necessary.

PASSPORT AND VISA REQUIREMENTS: **A valid passport for at least six months after the return date is required.** At the time of printing, U.S. citizens holding valid passports DO NOT REQUIRE visas or immunization for the country or countries being visited. Citizens of countries other than U.S. -- please contact the consulate of the country or countries being visited to determine visa requirements.

AIR TRANSPORTATION: Roundtrip international airfare is not included in the tour price. Travelers are responsible for arranging their own flights to and from the tour gateway according to arrival and departure instructions provided by the tour host. Please wait for final group arrival/departure guidance before purchasing non-refundable tickets.

PERSONAL AIRFARE: Travelers using air miles or personally purchased tickets should choose fares that can be changed without heavy fees and penalties, since airline schedules and group transfer timing are subject to change.

HOTEL ACCOMMODATIONS: Specially selected hotels based on twin occupancy with private bath. Single Room supplement of \$1,100 will be charged where requested and available. If you do not have a roommate and Holy Lands Sun Tours, Inc. is unable to arrange one, you will be billed for the single room supplement. All singles are subject to availability.

MEALS: The famous Israeli buffet breakfast and dinners are provided daily except where noted in the itinerary. An extra charge will be made when coffee, tea or other beverages are not included in the menu of the day with the dinner meal.
